Qualification:

- ITI in Branch / Subjects as specified above will ONLY be considered as eligible qualification.
- ITI in other than specified Branch / Subjects shall not be considered.
- The prescribed qualification should be from a recognized Indian University/Institute as a regular full time.
- Candidates possessing higher professional qualifications such as B.E. / B.Tech / MBA / MCA / CA / LLB or any such equivalent qualification shall not be eligible.

- Candidates holding a qualification acquired through part-time / correspondence / distance education mode are not eligible.
- The candidature of the applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information/certificate/ documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement, his/her engagement is liable to be terminated.

Age limit / Relaxation for candidates belonging to SC/ST/OBC Category:

- Certificate issued by a Board of Secondary Education for passing Matriculation / Higher Secondary shall be the only acceptable document in support of proof of age.
- Minimum 18 years and Maximum age shall be 27 years for General candidates as on 19.01.2025.
- Relaxation in age up to 5 years for SC/ST, 3 years for OBC, for IFFCO deceased employee dependent 3 Year will be allowed.

Apprenticeship period & Stipend:

Sl. No. 1 to11 - One Year. Rate of stipend payable to apprentices per month shall be as prescribed under Apprentices Act, 1961 & Apprentices Rules 1992 (as amended) and IFFCO's guidelines.

General Information:

- Online test and interview will be conducted, which will be intimated to eligible candidates.
- Active & correct Email id and mobile number must be mentioned in the application form. All future communications with candidates will take place through email.

Disqualification:

- The candidates who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in an Industry as per the Apprenticeship Act, 1961 & as amended from time to time or job experience for a period of 1 year or more are NOT eligible.

- If the received information in the application is incomplete, then the application will be rejected.
- Applications from candidates not meeting any criteria regarding qualification, age, year of passing shall be rejected.
