

While attending the Document verification, candidates should invariably bring following Documents/Certificates in **Original along with one set of self-attested photocopy.**

1. **Date of Birth:** Birth Certificate (or) SSLC/Matriculation certificate indicating Date of Birth.
2. **Educational Qualification:**
 - a) Matriculation mark sheet & Certificate issued by respective Educational Board
 - b) ITI mark sheet of all semesters
 - c) National Trade Certificate issued by NCVT or SCVT.
3. **SC/ST Certificate:** Community Certificate for SC/ST as per **Annexure- 'I'** issued by competent authority.
4. **OBC Certificate:** Community Certificate for OBC-NCL as per **Annexure-'II'** issued by competent authority. The Certificate should be latest i.e., issued within one year of the date of Document Verification and also valid for appointment/admission under the Government of India. A self-declaration as per **Annexure- 'II (A)'** should be executed by the candidate and to be submitted during Document Verification.
5. **Economically Weaker Section (EWS):** A certificate of Income and Asset in the prescribed format as per **Annexure- 'III'** issued by competent authority with the year of validity to be produced. The certificate should be latest i.e., valid on the date of Document Verification.
6. **Persons with Benchmark Disability:** Physical Disability certificate in the prescribed format as per **Annexure-'V (A)', 'V (B)', 'V (C)'** issued by Competent Authority. Certificates with Temporary Disability will not be entertained.
7. **Certificate of Medical Fitness:** During Document Verification candidates should submit Medical Certificate issued by Government Authorized Doctor (Gazetted) NOT BELOW THE RANK OF ASSISTANT SURGEON OF THE CENTRAL/STATE MEDICAL SERVICES in the prescribed format as per Apprentices Act 1961 and Para 4 of Apprentices Rules' 1992 (as amended time to time). The format is attached as **Annexure- 'B'**.
8. Candidates should also bring original AADHAAR card and PAN card along with one self-attested photocopy to submit during Document Verification.
9. **Ex-Servicemen:** Ex-Servicemen should submit Discharge Certificate and in case of children of Ex-Servicemen/Serving Armed Forces, Service Certificate is required to be submitted for availing reservation under Ex-Servicemen.

OTHER INSTRUCTIONS:

1. The candidates should get themselves registered on Apprenticeship Portal and bring the Registration number while reporting for Document Verification. The registration in Apprenticeship Portal should be 100% completed and to establish 100% completion of registration one printout is to be submitted at the time of Document Verification. Candidates are advised to visit Apprenticeship Portal at <https://www.apprenticeshipindia.gov.in> and register themselves for the Apprenticeship Registration Number. (It may be ensured that the name in the Apprenticeship Portal is same as in AADHAAR card).
2. Candidates may also note that being merely called for Document Verification does not confer any right on him/her for engagement as Act Apprentice in Railways.
3. The final selection of the candidates will be subject to verification of identity, all original certificates, and satisfying all criteria prescribed for the trade including Apprenticeship Portal registration 100% completed along with Medical Examination Standards as applicable.
4. All communications from CLW administration will be sent by SMS or email only and the **result of Document Verification will be uploaded in CLW's official website (<https://clw.indianrailways.gov.in/>) News & Recruitment** ➔ **Act Apprentice**. All SMS communications from CLW administration will only be made to the mobile number mentioned in the application. Candidates should maintain the same mobile number and email id till the selection is completed and CLW administration will not be responsible for non-receipt of communication due to change in his/her mobile number or email id.
