A notification was issued on 18/05/2026 for engagement of 1079 Nos of Act Apprenticeship (977-Nagpur Division & 102-Workshop/Motibagh) in Nagpur Division of S.E.C. Railway. The applications in this regard have been called Online. The opening date of submission of application was 19/05/2026 whereas closing was 18/06/2026.

The provisional list of short listed candidates equivalent to the extent of 7 times of the vacancies has been drawn out purely based on the aggregate of marks i.e. percentage of 10th plus ITI as filled by the candidates in their online application. Due to non-availability of PH & Ex-Serviceman candidates have been dragged by going down in the merit list and called for document verification.

- The final merit list will be published after verification of original certificate and subject to being found correct in verification in all respect.
- If it noticed by the Railway Administration that an applicant has furnished wrong information/fake certificate, the Railway Administration reserves the right to discharge the candidates/selected candidates at any stage without prior notice even though the selected candidates is undergoing training.
- Candidates are advised to bring all original documents in support of their qualification, latest community certificate, Discharge certificate for Ex. Serviceman, disability certificate, Aadhar card, Bank Account Passbook copy, Pancard, Check list for candidate & Declaration Form in the prescribed format issued by the competent authority. The candidates will have to produce downloaded Hard copy of applied application details from online Apprentice portal .
- Failure to produce the required document in proper format issued by the competent authority would lead to non-consideration of the candidature. Mere enlisting in the above provisional short listing does not confer any right for further consideration for engagement to the candidates.
- Candidates should also bring all original certificates and a copy of one set of all certificates (Self attested) and the same will be retained by the office.
- The candidates availing the benefits of reservation of Ex-serviceman must produce the discharge certificate from the force during document verification.
- PWD availing the benefits of reservation of disability must produce the disability certificates issued by the competent authority at the time of document verification.
- Candidates falling or belongs to EWS category are advised to come with Income & Asset certificate issued by appropriate authority at the time of Document Verification.
- No daily allowance/conveyance allowance or travelling allowance will be paid to the candidates called for document verification.
- Candidates are hereby advised not to fall prey to any unscrupulous elements promising to give engagement as Act Apprentice in Railways. The engagement is purely based on merit and only the genuine candidates found suitable in all respect will be considered.
- Request for change of information once filled during online application will not be considered during document verification. Hence, candidates should ensure correct information in their respective hard copy of online application in reference to the certificate before coming for document verification.
